### **Guidelines for Golf Cart Use**

- All Golf carts must have liability insurance at the minimum amount of \$100,000. Proof of liability insurance must be provided with registration.
- Only 1 Golf Cart permitted per Seasonal Site.
- Stay on roads or designated golf cart paths. Follow the same rules as automobiles. 5 MPH.
- No reckless driving
- No political flags, stickers or treasures. No profanity or inappropriate markings of any kind. Nothing controversial.
- Golf carts must be parked in designated parking areas when visiting the pool area & common areas. Do not block walkways, paths or roadways. Golf carts are not permitted in the front parking lot. Golf carts may not go through the security gate (only
- in case of an emergency).
- You are responsible for your golf cart at all times.
- Only 21+ Seasonal Campers with a valid driver's license are permitted to drive a golf cart.
- No Drinking Alcohol when driving. Do not operate if under the influence of alcohol or drugs.
- No loud music. Keep the noise level low. Be respectful of fellow campers in the park.
- All 21+ drivers must be registered in the office and be listed as an insured driver on your policy.
- No hanging off the cart or off the back (must be always sitting on the seat). Wear your seatbelt (if the cart is equipped with them). No children on driver's lap when operating cart.
- Approach turns slowly and with caution. Watch out for children and families on bikes, people walking, pets and watch for other cars. Pull to the side and let others pass you.
- Do not operate without park/campground approval. Registration and Contract must be on file.
- Remove Keys when cart is not in use or left unattended.
- Do not exceed manufacturer specs for number of occupants. 4-seater seats 4 people only no more. We do not allow 6-person Golf Carts.
- Use turn signals and lights when driving at night. Must have working lights (2 headlights or two bulb bar lights) and rear lights or reflectors. Use turn signals.
- Golf carts must remain on their registered site during quiet hours (Sunday – Thursday 10 pm - 9am & Friday and Saturday 11pm -9am).

- Registered Golf Carts will be plugged into your own metered electric box. Seasonal pays for electric. We suggest you plug in at night when it's cooler.
- All Camp Rules still apply including road signs and speed limits.
- Any infraction of rules will be reviewed and if necessary, have privileges revoked and under extreme circumstances ejected from the park with NO REFUND.
- The driver must follow the Full List of Rules on your Seasonal Contract, Stateline Website and On the Map in the office
- The cart must be in good order. No "modified" or "Lifted" carts allowed without prior office approval. A photo must be provided prior to being brought into the park.
- Park only in designated areas. No carts allowed beyond the Security Gate (in the front lot).
- All golf carts must be numbered on both sides with the owner's site number in 4" black letters.
- Permanent shelters or garages for carts are expressly prohibited.
- Resort Camplands Int. Inc. DBA Stateline Campresort & Cabins is not liable for any damage to golf carts, including but not limited to, loss and vandalism. Unit owners' liability includes, but is not limited to, any loss, injury, or damage caused by said golf cart.
- This Seasonal privilege of allowing golf carts is on a trial basis. If rules are not adhered to by the majority, this privilege can and will be revoked. Your purchasing a gold cart is at your own free will. There is no guarantee this benefit will be available in the future.
- Management reserves the right to amend or modify rules as deemed necessary (at any time).
- Enjoy your Golf Cart and Drive Responsibly.
